


ASI TARGETED GRAZING GOAL


Promote the use of targeted grazing by increasing the awareness of this ecosystem management practice among land managers and improving the quality of services delivered by targeted grazing providers.

 - Agrivoltaics








TARGETED GRAZING RESPONDENTS

75% of respondents grazed in more than 1 state.




PERCENT OF CONTRACTORS THAT HAVE BEEN IN BUSINESS MORE THAN 5 YEARS




GROWTH OF TARGETED GRAZING BY SIZE AND YEARS IN BUSINESS






WHAT AREAS OF TARGETED GRAZING HAVE YOU WORKED IN?

TYPES OF TARGETED GRAZING PROJECTS





OTHER TYPES OF TARGETED GRAZING PROJECTS


- Brush mitigation post tree thinning

- To reduce mowing especially in areas with difficult terrain


Percent of Respondents (n = 99) and Classes of Livestock




TYPE AND NUMBER OF LIVESTOCK RESPONDENTS GRAZED 54,450 HD OR 12,000 AUE




Average Number of Animal Unit Equivalents per Respondent from All Classes of Livestock




HOW LONG DID IT TAKE FOR YOUR LIVESTOCK TO BECOME PROFICIENT AT TARGETED GRAZING?



SUPPLEMENTS USED IN TG PROJECTS




HOW DO YOU KEEP LIVESTOCK ON TARGETED GRAZING AREA?






HOW MANY MONTHS OF THE YEAR ARE YOU ON PAID PROJECTS?




HOW DO YOU CHARGE FOR TARGETED GRAZING?




AVERAGE PRICE PER ACRE FOR TARGETED GRAZING SERVICES BY REGION



AVERAGE PRICE PER ACRE FOR TARGETED GRAZING SERVICES BY SPECIES




DO YOU HAVE A WRITTEN CONTRACT FOR TARGETED GRAZING JOBS?




MONITORING

 - 60% both





WHY WOULD YOU REFUSE A PROJECT?

- The person or organization wanting to use targeted grazing has unrealistic expectations
- The job requires more resources than I have
- High potential liability
- Dangerous conditions for stock
- Grazing may do more damage to the site; the source of the weeds aren't being addressed
- High level of poisonous plants
